

During open meeting on February 14, 2012, in Austin, Texas, the Texas Board of Nursing considered the Motion for Rehearing filed in the above-styled matter. The Eligibility and Disciplinary Committee of the Board approved an order on June 14, 2011, revoking permanent certificate numbers **713888 & 181009** issued to **KARI KRISTINA MCKINLEY**.
