ORDER OF THE BOARD

On this day, the Texas Board of Nursing, hereinafter referred to as the Board, accepted the voluntary surrender of Registered Nurse License Number 532263, issued to VICKI HELEN MCLEAN, hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c), Texas Occupations Code.

Respondent waived representation by counsel, informal proceedings, notice and hearing.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Respondent is currently licensed to practice professional nursing in the State of Texas.
2. Respondent waived representation by counsel, informal proceedings, notice and hearing.
3. Respondent received a Diploma in Nursing from Our Lady of the Lake, School of Nursing, Baton Rouge, Louisiana, in November 1976. Respondent was licensed to practice professional nursing in the State of Texas on July 31, 1986.

5. On or about May 6, 2008, the Texas Board of Nursing accepted the Voluntary Surrender of Respondent's license to practice professional nursing in the State of Texas. A copy of the Findings of Fact, Conclusions of Law and Order of the Board dated May 6, 2008, is attached and incorporated herein, by reference, as part of this Order.

6. On or about May 19, 2010, Respondent's license to practice professional nursing in the State of Texas was REINSTATED by the Texas Board of Nursing. A copy of the Findings of Fact, Conclusions of Law and Order dated May 19, 2010, is attached and incorporated herein, by reference, as part of this Order.

7. On October 27, 2010, the TPAPN informed the Texas Board of Nursing that Respondent withdrew from TPAPN after she had been referred for an immediate psychological

evaluation, but refused treatment.

8. On or about October 24, 2010, the Board received a notarized statement from Respondent voluntarily surrendering the right to practice nursing in Texas. A copy of Respondent's statement, dated October 23, 2010, is attached and incorporated herein, by reference, as part of this Order.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove a violation of Section 301.452(b)(10)&(12), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(5),(9)&(11)(B).
4. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
5. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.
6. Any subsequent reinstatement of this license will be controlled by Section 301.452 (b), Texas Occupations Code, and 22 TAC§§213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

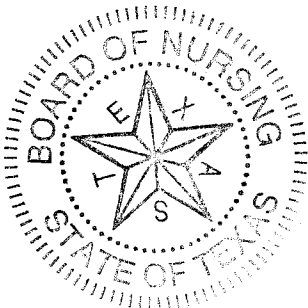
ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of Registered Nurse Vocational Nurse License Number 532263, heretofore issued to VICKI HELEN MCLEAN, to practice professional nursing in the State of Texas, is accepted by the Executive Director on behalf of the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

1. RESPONDENT SHALL NOT practice professional nursing, use the title of "registered nurse" or the abbreviation "RN" or wear any insignia identifying herself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.
2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order.
3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice professional nursing in the State of Texas.

On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the Petition for Reinstatement of VICKI HELEN MCLEAN, Registered Nurse License Number 532263, hereinafter referred to as Petitioner.

An informal conference was held on May 4, 2010, at the office of the Texas Board of Nursing, in accordance with Section 301.464 of the Texas Occupations Code.

PETITIONER appeared in person. PETITIONER was notified of her right to be represented by legal counsel and elected to waive representation by counsel. In attendance were Bonnie Cone, MSN, RN, Nursing Consultant, Executive Director's Designee; Mary Beth Thomas, PhD, RN, Director of Nursing; Kyle Hensley, Assistant General Counsel; Anthony L. Diggs, MSCJ, Director, Enforcement Division; Dominique Mackey, Investigator; and Diane E. Burell, Investigator.

FINDINGS OF FACT

1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Petitioner and Petitioner was given an opportunity to show compliance with all requirements of the law for retention of the license.
2. Petitioner waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.
3. Petitioner received a Diploma in Nursing from Our Lady of the Lake, School of Nursing, Baton Rouge, Louisiana, in November 1976. Petitioner was licensed to practice professional nursing in the State of Texas on July 31, 1986.

5. On May 8, 2008, the Board accepted the voluntary surrender of Petitioner's license to practice professional nursing in the State of Texas. A copy of the May 8, 2008, Agreed Order, Findings of Fact, and Conclusions of Law, is attached and incorporated, by reference, as a part of this Order.
6. On or about January 26, 2010, Petitioner submitted a Petition for Reinstatement of License to practice vocational nursing in the State of Texas.
7. Petitioner presented the following in support of her petition:
 - 7.1. Medical records from Rusk State Hospital dating from March 5, 2009, through May 28, 2009.
 - 7.2. Medical Records from Tri-County MHMR Services dating from June 16, 2009, through March 4, 2010.
 - 7.3. Evaluation and Progress Notes from Pam Rall, Petitioner's therapist.
 - 7.4. Letter, dated March 4, 2010, from Laura Champagne, MD, Tri-County MHMR, Conroe, Texas, states Petitioner is currently a patient and has been diagnosed with Bipolar I Disorder, Single Manic Episode, Severe with Psychotic Features. Petitioner is provided with Pharmacological Management, Nursing Services, and Case Coordination. Petitioner has been in outpatient services with Tri-County MHMR since June 2009. To date, she has made all scheduled appointments which occur every eleven (11) weeks. It is Dr. Champagne's opinion that Petitioner is stable and may continue to be a practicing nurse.
 - 7.5. Letter, dated April 8, 2010, from Jennifer Screws, LPC, NCC, RPT, Depression and Bipolar Support Alliance, Houston, Texas, states Petitioner has attended support groups nine (9) times since January 12, 2010.
 - 7.6. Letter from Conn McWhorter, The Woodlands Church, states Petitioner has completed the GriefShare program at the church. GriefShare is a thirteen (13) week long video and curriculum-based program that guides people through their grief experience. There is a daily workbook that is issued to each participant and each meeting consists of a small group time for sharing, accountability, and prayer. Mr. McWhorter feels Petitioner has benefitted from attending.

- 7.7. Letter of support, dated March 5, 2010, from Georgia Marnell, Metairie, Louisiana, states she is writing in reference to the well being of her sister, Vicki McLean. Ms. Marnell states she stays in contact with Petitioner on a regular basis. She is now a healthy person both mentally and physically. Ms. Marnell believes Petitioner has made great strides in her mental health because she has a clear picture of herself and has taken the steps to get well. Petitioner always takes her medication and attends her psychiatrist and therapy meetings regularly. Petitioner also spends time volunteering for a Woman's Shelter. She stays in touch with family and friends and is very involved with her church. Petitioner always was, and still is a very caring person. She is someone who is honest, and always available to help out.
- 7.8. Letter of support, dated March 27, 2010, from Timothy McLean, The Woodlands, Texas, states Petitioner is of strong mental and emotional health. She has diligently addressed all of her previous shortcomings and has developed a life regimen that furthers her progress every day. Petitioner has gained a full understanding of her bipolar diagnosis and successfully treats it daily. She attends bipolar support groups to further ensure that her diagnosis will not hinder her life goals. Petitioner has successfully completed grief counseling and continues to attend personal counseling. She volunteers at a non-profit organization once a week, and is an active member of The Fellowship of The Woodlands Church. The most important step of Mr. McLean's mother's progress was surrounding herself with a strong support system. Close family now live five (5) minutes of each other and see each other multiple times a week and talk every day. This process has brought all of them closer. This constant communication makes Mr. McLean confident that his mother is here to stay and is more capable now than he has ever known.
- 7.9. Letter of support, dated March 1, 2010, from Elizabeth Glass and Claydean Buchanan, Assistant Managers, Rags to Riches, Montgomery County Women's Center, The Woodlands, states Ms. Glass and Ms. Buchanan highly recommend Petitioner as a valuable worker. She has been a volunteer for the Montgomery County Women's Center for six (6) months, committing two (2) full days a week for her time to the non-profit store. Petitioner is very dependable; as she is always on time and present on the days she is scheduled to work. Petitioner is very friendly, helpful, and works well with others. Furthermore, she does an outstanding job at organizing and using her innovative ideas to find the best solution she can to any obstacle and to improve business.
- 7.10. Letter of support, dated February 27, 2010, from Keith Harrison, The Woodlands, Texas, states Petitioner is an active member of The Woodlands Church and is involved in many areas within the church. She regularly attends in the Single's Ministry, volunteers and consistently contributes financially to the church. As pastor of the church, Mr. Harrison wholeheartedly endorses Petitioner and hopes that the Board will consider allowing her to continue as a nurse in Texas.

- 7.11. Letter of support, dated March 1, 2010, from Kim McLean, The Woodlands, states she is Petitioner's daughter and keeps in touch with her frequently. Ms. McLean lives nearby and they see each other often. Ms. McLean is able to call Petitioner and ask her advice on relationships and work situations, and she provides Ms. McLean with very logical advice. Petitioner informs Ms. McLean that she is taking her medication regularly and understands how it helps her. She attends her bipolar support groups regularly. Ms. McLean is confident that Petitioner is in a great state and able to resume her career in the nursing field.
 - 7.12. Letter of support, dated February 23, 2010, from Glen Fanning, Baton Rouge, Louisiana, states he is writing on behalf of his sister. She is honest, knowledgeable and a very hard worker. Mr. Fanning is grateful that his sister has accepted that she is bipolar and is willing to stay on medication to have peace and serenity in her life. The sister that he cared about and loved is back in his life because she is open, willing and honest with herself and other today. Mr. Fanning is part of Petitioner's support system and they speak several times a week about her therapy, medication, family, friends and life. Mr. Fanning is excited and encouraged about Petitioner's willingness to get her nursing license reinstated. She is an excellent worker because she is dependable, honest and knowledgeable in the field of nursing.
 - 7.13. Letter of support, dated February 23, 2010, from Lori Fanning Tozel, Baton Rouge, Louisiana, states she is writing on behalf of her sister. Petitioner has received help for her bipolar disorder. More importantly, she has reached out for her strength, love and support from her eight (8) brothers and sisters and two (2) grown children. Petitioner has put forth the same great effort working on herself as she has tackled every challenge in her life, past and present. Petitioner has a strong faith and has been involved in church. She spends her time volunteering and helping others. She continues to educate herself about her disease. She attends therapy sessions and talks very openly on a regular basis. Ms. Tozel believes Petitioner would be an asset not only to the medical field, but to every patient she touches as a nurse.
 - 7.14. Verification of successful completion of twenty (20) Continuing Education Contact Hours.
8. Petitioner's compliance with the terms of a Board approved peer assistance program should be sufficient to protect patients and the public.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Pursuant to Section 301.467, Texas Occupations Code, the Board may refuse to issue or renew a license, and may set a reasonable period that must lapse before reapplication.
3. Pursuant to 22 TEX. ADMIN. CODE §213.26, the Board may impose reasonable conditions that a Petitioner must satisfy before reissuance of an unrestricted license.

ORDER

IT IS THEREFORE AGREED, subject to ratification by the Texas Board of Nursing, that the petition of VICKI HELEN MCLEAN, Registered Nurse License Number 532263, to practice nursing in the state of Texas, be and the same is hereby GRANTED SUBJECT TO THE FOLLOWING CONDITIONS SO LONG AS THE PETITIONER complies in all respects with the Nursing Practice Act, Texas Occupations Code, §301.001 *et seq.*, the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.1 *et. seq.* and the stipulations contained in this Order.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Petitioner's nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Petitioner's license is encumbered by this Order, Petitioner may not work outside the State of Texas pursuant to a nurse licensure compact privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Petitioner wishes to work.

(1) PETITIONER SHALL NOT seek employment or practice nursing for compensation until she has paid all re-registration fees and is issued a license to practice nursing in the State of Texas. Said licenses issued to VICKI HELEN MCLEAN, shall be subject to the following agreed post-licensure stipulations:

(2) PETITIONER SHALL, within forty-five (45) days of relicensure, apply to TPAPN which SHALL, within ninety (90) days following relicensure, sign and execute the TPAPN participation agreement, which SHALL include payment of a non-refundable participation fee in the amount of five hundred dollars (\$500.00) payable to TPAPN.

(3) Upon acceptance into the TPAPN, PETITIONER SHALL waive confidentiality and provide a copy of the executed TPAPN contract to the Texas Board of Nursing.

(4) PETITIONER SHALL comply with all the requirements of the TPAPN participation agreement during its term and SHALL keep her license to practice nursing in the State of Texas current.

(5) PETITIONER SHALL CAUSE the TPAPN to notify the Texas Board of Nursing of any violation of the TPAPN contract.

IT IS FURTHER AGREED, SHOULD PETITIONER fail to comply with this Order or the terms of the participation agreement with the TPAPN, such noncompliance will result in further disciplinary action including EMERGENCY SUSPENSION pursuant to Section 301.4551, Texas Occupations Code, or REVOCATION of PETITIONER's license and nurse licensure compact privileges, if any, to practice nursing in the State of Texas.

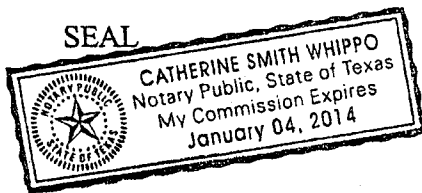





FORMAL CHARGES

This is a disciplinary proceeding under Section 301.452(b), Texas Occupations Code. Respondent, VICKI HELEN MCLEAN, is a Registered Nurse holding license number 532263, which is in current status at the time of this pleading.

Written notice of the facts and conduct alleged to warrant adverse licensure action was sent to Respondent at Respondent's address of record and Respondent was given opportunity to show compliance with all requirements of the law for retention of the license prior to commencement of this proceeding.

CHARGE I.

On or about August 22, 2005 and August 24, 2005, while employed with Cleveland Regional Medical Center, Cleveland, Texas, Respondent lacked fitness to practice professional nursing in that:

- a. Respondent told patient medical record number 000069881 that she was investigating murders in the area and that she feared for her life because the mafia was after her and they had already tried to kill her. While discharging the patient Respondent gave her the prescriptions that the physician had written and she told her "I have to give you these but you should not fill them, you don't need them and it is just one more way for the doctor to get you back in his office for another visit. It's all about the money."
- b. Respondent informed her Supervisor that she had just spent the last two (2) weeks in a psychiatric facility where her brother had her committed and that she was put on the medication Geodon while in the facility. Respondent also told the Supervisor that "I am not crazy, I am telling you my life is in danger, my phones are tapped and the Chinese mafia has a hit out on me right now because of the dirty land deals I am investigating which are involved in cocaine trafficking from South America."
- c. Respondent told her Supervisor that God had previously spoken to Respondent through her, that she would do whatever the Supervisor thought best, and she would take it as a sign of what she should do.
- d. On August 24, 2005, Respondent contacted her Supervisor and told her that Respondent was in New Orleans and that she was resigning her position. Respondent told her that she could not say much because the phones were tapped but that she needed to complete her investigations on dirty land deals in a safer place.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10)&(12), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(1)(E)&(5).

CHARGE II.

On August 23, 2006, Respondent submitted a License Renewal Form to the office of the Texas Board of Nursing on which she answered "Yes" to the following question "In the past 5 years, have you been diagnosed with or treated or hospitalized for schizophrenia or other psychotic disorder, bipolar disorder, paranoid personality disorder, antisocial personality disorder, or borderline personality disorder? (You may answer "no" if you have completed and/or are in compliance with TPAPN for mental illness)". Respondent disclosed that she was involuntarily committed to a psychiatric hospital by her brother and was diagnosed with Schizophrenia which she states is not an accurate diagnosis.


The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(10)&(12), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(1)(E)&(5).

NOTICE IS GIVEN that staff will present evidence in support of the recommended disposition of revocation of Respondent's license to practice nursing in the State of Texas pursuant to the Board's rules, 22 TEX. ADMIN. CODE §§ 213.27 - 213.33. and TEX. OCC. CODE Ch. 53. Additionally, staff will seek to impose on Respondent the administrative costs of the proceeding pursuant to § 301.461, TEX. OCC. CODE ANN. The cost of proceedings shall include, but is not limited to, the cost paid by the board to the State Office of Administrative Hearings and the Office of the Attorney General or other Board counsel for legal and investigative services, the cost of a court reporter and witnesses, reproduction of records, board staff time, travel, and expenses. These shall be in an amount of at least one thousand two hundred dollars (\$1200.00).



According to my order to comply with TPAPN I am required to get a nurse job agreeing to all the restrictions placed on me by the Texas Board of Nursing. In my hearing on March 5, 2008 it was well known by the documents presented that I became a federal whistleblower reporting violations of the rule and regulations by my employer Select Medical Corporation. Numerous documents were presented to prove my whistleblower status. Numerous documents proved the continual harassment and retaliation I received which included the pursuing of my registered nurse license in 2006 based on falsified documents to cause an illegal psychiatric admission by East Jefferson General Hospital which was one of the host hospitals of Select Medical Corporation that I reported to the Office of Inspector General for illegal billing. These actions forced me to hire Attorney Constance Singleton in July 2006 to pursue the QuiTam case against Select Medical Corporation, HCA, East Jefferson General Hospital, and Blue Cross Blue Shield Association. In my hearing on March 5, 2008 it was revealed that I discussed with Attorney Singleton's associate by cell phone on Dec. 17th or 18th, 2006 of the importance of filing the QuiTam case before the Dec. 31, 2006. It also was revealed that Attorney Singleton was stabbed 6 times on Dec. 22, 2006 to stop the filing of the QuiTam Case. Numerous other retaliations continued to occur in my life. On March 2, 2008 I returned home after working the night shift

and recognized someone had been in my home since my door was left wide open. I called 911 and filed a police report. This continued to happen several times after and I called 911. On March 2, 2008 in order to stop me from pursuing the QuiTam case filed in New Orleans I was accused of calling Judge Carol Woods and threatening her on a Sunday which was not true.

Due to all of this harassment and retaliation of a federal whistleblower which has tarnished my perfect record and labeled me bipolar when I am not it has been reasonable to expect that I would not be able to find a job with all the other restrictions placed upon me by the Texas State Board of Nursing. I have applied to numerous hospital positions and home health positions, etc. I have complied with all the requirements placed on me by the Texas State Board of Nursing and TPAPN. I have applied continual for over a period of 90 days to seek employment as a registered nurse that complies with all the restrictions placed on me by the Texas State Board of Nursing. I have gone on 2 interviews. My therapists, my family and myself have come to the realization that I am likely on a black ball list due to my discovery of a minimum of 80 acute care hospitals, along with our governmental contract payer, Blue Cross Blue Shield Association violating the rules and regulations for billing Medicare for Long Term Acute Care. The chances of getting a job as a nurse is very slim to none.

No longer wishing to live in Texas and waste my time pursuing a nursing job with such slim chances of getting one I have decided to voluntarily surrender my Texas registered nurse license. I would hope that I get the prepaid TPAPN expenses refunded to me since my voluntarily surrendering my license will end my relationship not only with the Texas State Board of Nursing but also with TPAPN.

Because of East Jefferson General Hospital labeling me in a state of psychosis because I claimed I was a Federal Whistleblower I feel it important to include with this letter the following documents that prove in fact that I have been a very powerful federal whistleblower that even resulted in organized white collar crime to stab my Attorney Singleton 6 times and have it assigned to robbery for a little old purse. Attorney Singleton's wounds were so deep that she was in ICU for 4 days and the total hospital stay was 10 days.

The following documents have been included in this voluntarily surrendering of my license to make it fully clear that my record has been tarnished due to no fault of my own:

1. Letter from the District Attorney Office of Harris County in regards to the stabbing of Attorney Singleton.
2. Copy of my check given to Attorney Singleton for \$15,000 to file the QuiTam case against Select Medical Corporation, Blue Cross Blue Shield Association, HCA, and East Jefferson General Hospital.
3. QuiTam filing in US 5th District Court in New Orleans.
4. Letters received from the following agencies after receiving the Select Report: Ernest and Young, LLP, Office of Inspector General, TriCenturion refusing to acknowledge the report was about hospital illegal billing not physician illegal billing, Internal affairs of Houston Police Dept.
5. Police report on 3/2/2008, 911 calls on 3/2/2008, 3/9/2008, 3/13/2008
6. Hospital admissions by West Jefferson hospital and East Jefferson Hospital which reveals that East Jefferson Hospital documents my presence in their hospital just 12 minutes after discharged from West Jefferson Hospital which is impossible due to the driving distance and time it took to eat. Along with statements from my sister and brother which verifies falsified documentation produced by East Jefferson General Hospital which is very different from West Jefferson General Hospital.
7. My comment on website in regards to the "Michael Clayton" movie on Feb. 24, 2008 just 8 days before my hearing on 3/5/2008 indicating that the Texas State Board of Nursing participated in receiving information from organized white collar crime when they tapped my internet, phone, etc.

Most of these documents were presented in my Texas State Board of Nursing hearing on 3/5/2008. The BON at the bottom of the pages prove they were included in the hearing.

I, Vicki Helen McLean, am voluntarily surrendering my Texas registered nurse license # 532263 today on 10/23/2010.

I am requesting that you notify my case manager Terry Shockley from TPAPN immediately that I no longer am required to participate in the program since I have surrendered my license so I can live in Louisiana by my family.
