5. On or about April 14, 2010, the Board provided Respondent with notice of alleged violations of the Nursing Practice Act of the State of Texas, which included, in relevant part:

That, on or about February 24, 2010, while working as an Agency Nurse with Royalty Staffing Solutions, Houston, Texas, and assigned to Nexus Specialty Hospital, Shenandoah, Texas, Respondent left the facility without notifying her supervisor and, in so doing, abandoned the six (6) patients that had been assigned to her care.

Respondent's conduct, as alleged, was likely to injure patients.

6. On or about July 12, 2010, Respondent submitted a written statement to the Board voluntarily granting the Board permission to revoke her license, i.e., voluntarily surrendering the right to practice vocational nursing in Texas. A copy of Respondent's statement, dated July 6, 2010, is attached and incorporated herein by reference as part of this Order.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.

3. The evidence received is sufficient to prove violation of Section 301.452(b)(10), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(12).
4. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
5. Under Section 301.453(d), Texas Occupations Code, the Board may impose conditions for reinstatement of licensure.
6. Any subsequent reinstatement of this license will be controlled by Section 301.452 (b), Texas Occupations Code, and 22 TAC §§213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

ORDER

NOW, THEREFORE, IT IS ORDERED that the voluntary surrender of Vocational Nurse License Number 157662, heretofore issued to April Kay Moreland, to practice vocational nursing in the State of Texas, is accepted by the Executive Director on behalf of the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

1. RESPONDENT SHALL NOT practice vocational nursing, use the title of vocational nurse or the abbreviation LVN or wear any insignia identifying herself as a vocational nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.
2. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order.
3. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's nurse licensure compact privileges, if any, to practice vocational nursing in the State of Texas.
