**ORDER OF THE BOARD**

TO: Shona Kay Burrage

New Caney, Texas 77357

During open meeting held in Austin, Texas, on Tuesday, March 23, 2010, the Eligibility and Disciplinary Committee (hereinafter "Committee") heard the above-styled case. This case was heard, and based on the failure of the Respondent to appear as required by 22 TEX. ADMIN. CODE Ch. 213.

The Committee of the Texas Board of Nursing finds that notice of the facts or conduct alleged to warrant disciplinary action has been provided to Respondent in accordance with Texas Government Code § 2001.054(c) and Respondent has been given an opportunity to show compliance with all the requirements of the Nursing Practice Act, chapter 301 of the Texas Occupations Code, for retention of Respondent's license to practice vocational nursing in the State of Texas.

The Committee finds that the Formal Charges were properly initiated and filed in accordance with section 301.458, Texas Occupations Code.

The Committee finds that after proper and timely Notice regarding the violations alleged in the Formal Charges was given to Respondent in this matter, Respondent has failed to appear in accordance with 22 TEX. ADMIN. CODE Ch. 213.

The Committee finds that the Board is authorized to enter a default order pursuant to Texas Government Code § 2001.056.

The Eligibility and Disciplinary Committee, after review and due consideration, adopts the proposed findings of fact and conclusions of law as stated in the Formal Charges which are attached hereto and incorporated by reference for all purposes and the Staff's recommended sanction of revocation by default. This Order will be properly served on all parties and all parties will be given an opportunity to file a motion for rehearing (22 TEX. ADMIN.CODE § 213.2(j)). All parties have a right to judicial review of this Order.

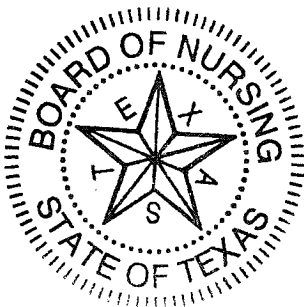
All proposed findings of fact and conclusions of law filed by any party not specifically adopted herein are hereby denied.

### FORMAL CHARGES

This is a disciplinary proceeding under Section 301.452(b), Texas Occupations Code. Respondent, SHONA KAY BURRAGE, is a Vocational Nurse holding license number 117690, which is in current status at the time of this pleading.

Written notice of the facts and conduct alleged to warrant adverse licensure action was sent to Respondent at Respondent's address of record and Respondent was given opportunity to show compliance with all requirements of the law for retention of the license prior to commencement of this proceeding.

#### CHARGE I.

On or about February 28, 2009, Respondent became non-compliant with the Reinstatement Agreed Order issued to her by the Texas Board of Nursing on December 21, 2007. Non-compliance is the result of her failure to comply with the Texas Peer Assistance Program for Nurses' (TPAPN) return to work agreement. Stipulation number four (4) of the Agreed Order dated December 21, 2007, states:

"PETITIONER SHALL comply with all the requirements of the TPAPN contract during its term."

A copy of the Findings of Fact, Conclusions of Law and Agreed Order dated December 21, 2007, is attached and incorporated, by reference, as part of this pleading.

The above action constitutes grounds for disciplinary action in accordance with Section 301.452(b)(1)&(10), Texas Occupations Code, and is a violation of 22 TEX. ADMIN. CODE §217.12(9).

NOTICE IS GIVEN that staff will present evidence in support of the recommended disposition of up to revocation of Respondent's license to practice nursing in the State of Texas pursuant to the Board's rules, 22 TEX. ADMIN. CODE §§ 213.27 - 213.33. Additionally, staff will seek to impose on Respondent the administrative costs of the proceeding pursuant to § 301.461, TEX. OCC. CODE ANN. The cost of proceedings shall include, but is not limited to, the cost paid by the Board to the State Office of Administrative Hearings and the Office of the Attorney General or other Board counsel for legal and investigative services, the cost of a court reporter and witnesses, reproduction of records, Board staff time, travel, and expenses. These shall be in an amount of at least one thousand two hundred dollars (\$1200.00).



On this day came to be considered by the Texas Board of Nursing, hereinafter referred to as the Board, the Petition for Reinstatement of Vocational Nurse License Number 117690, held by SHONA KAY BURRAGE, hereinafter referred to as Petitioner.

An informal conference was held on October 2, 2007, at the office of the Texas Board of Nursing, in accordance with Section 301.464, Texas Occupations Code.

Petitioner appeared in person. Petitioner was notified of her right to be represented by legal counsel and elected to waive representation by counsel. In attendance were Mary Beth Thomas, PhD, RN, Director of Nursing, Executive Director's Designee; Rachel Gomez, LVN, Board Member; Victoria Cox, Assistant General Counsel; Anthony L. Diggs, MSCJ, Director of Enforcement; Mike Abul-Saud, RN, Investigator; and Carolyn Hudson, Investigator.

FINDINGS OF FACT

1. Prior to institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Petitioner and Petitioner was given an opportunity to show compliance with all requirements of the law for retention of the license.
2. Petitioner waived notice and hearing, and consented to the entry of this Order.
3. Petitioner received a Certificate in Vocational Nursing from Kingwood College, Kingwood, Texas, on December 19, 1986. Petitioner was originally licensed to practice vocational nursing in the State of Texas on May 20, 1987.

4. Petitioner's vocational nursing employment history included:

5. On December 2, 2003, Petitioner voluntarily surrendered her license to practice vocational nursing in the State of Texas, and the license was subsequently revoked by the Board of Vocational Nurse Examiners for the State of Texas. A copy of the December 2, 2003, Order of the Board is attached and incorporated, by reference, as a part of this Order.
6. On or about May 25, 2007, Petitioner submitted a Petition for Reinstatement of License to practice vocational nursing in the State of Texas.
7. Petitioner presented the following in support of her petition:
- 7.1. Letter of support, dated January 25, 2006, from Kristin Wilson, Community Supervision Officer, Montgomery County Department of Community Supervision and Corrections Department, New Caney, Texas, states that Petitioner was placed on a three (3) year period of deferred adjudication community supervision on February 11, 2004, for the offense of Possession of Controlled Substance by Fraud. Petitioner

complied with the conditions of supervision and was an exemplary probationer. Ms. Wilson states that Petitioner submitted four (4) urine specimens to be tested for the presence of alcohol and drugs and all test results were negative for prohibited substances. Petitioner was granted early discharge from probation on November 1, 2005.

- 7.2. Letter of support, dated January 11, 2006, from Laurie Hiatt, LBSW, Social Worker, The Mission, New Caney, Texas, states that Petitioner began working at The Mission in March 2004 as a community service worker in helping the less fortunate in obtaining assistance with food and clothing. Petitioner is honest and trustworthy. Ms. Hiatt states that Petitioner continued to volunteer at the Mission after she completed her community service in August 2004. Ms. Hiatt recommends reinstatement of Petitioner's nursing license.
  - 7.3. Letter of support, dated January 24, 2006, from Mary L. Deason, Supervisor, Mission Northeast, New Caney, Texas, states that Petitioner worked for the Mission to complete community service and was placed in the position of managing the clothing warehouse. Petitioner did a wonderful job in managing a very busy department. Ms. Deason states that Petitioner is a compassionate person and she would be an asset to the nursing community.
  - 7.4. Verification of successful completion of twenty (20) Type I Continuing Education Contact Hours.
8. Petitioner gives July 2003, as her date of sobriety.

#### CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Pursuant to Section 301.467, Texas Occupations Code, the Board may refuse to issue or renew a license, and may set a reasonable period that must lapse before reapplication.
3. Pursuant to 22 TEX. ADMIN. CODE §213.26, the Board may impose reasonable conditions that a Petitioner must satisfy before reissuance of an unrestricted license.



ORDER

IT IS THEREFORE AGREED, subject to ratification by the Texas Board of Nursing, that the petition of SHONA KAY BURRAGE, Vocational Nurse License Number 117690, to practice vocational nursing in the state of Texas, be and the same is hereby GRANTED SUBJECT TO THE FOLLOWING CONDITIONS SO LONG AS THE PETITIONER complies in all respects with the Nursing Practice Act, Texas Occupations Code, §301.001 *et seq.*, the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.01 *et. seq.* and the stipulations contained in this Order:

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Petitioner's multistate licensure privilege, if any, to practice vocational nursing in the State of Texas

IT IS FURTHER AGREED and ORDERED that while Petitioner's license is encumbered by this Order, Petitioner may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Petitioner wishes to work.

(1) PETITIONER SHALL NOT seek employment or practice nursing for compensation until she has paid all re-registration fees and is issued a license to practice vocational or professional nursing in the State of Texas, which shall bear the appropriate notation. Said licenses issued to SHONA KAY BURRAGE, shall be subject to the following agreed post-licensure stipulations:

(2) PETITIONER SHALL, within forty-five (45) days following the date of entry of this final Order, apply to and be accepted into the TPAPN, which SHALL include payment of a non-refundable participation fee in the amount of three hundred fifty dollars (\$350) payable to TPAPN.

(3) Upon acceptance into the TPAPN, PETITIONER SHALL waive confidentiality and provide a copy of the executed TPAPN contract to the Texas Board of Nursing.

(4) PETITIONER SHALL comply with all the requirements of the TPAPN contract during its term.

(5) PETITIONER SHALL CAUSE the TPAPN to notify the Texas Board of Nursing of any violation of the TPAPN contract.

IT IS FURTHER AGREED, SHOULD PETITIONER fail to comply with this Order or the terms of the participation agreement with the TPAPN, such noncompliance will result in further disciplinary action including revocation of Petitioner's license and multistate licensure privileges, if any, to practice vocational nursing in the State of Texas.



PETITIONER'S CERTIFICATION

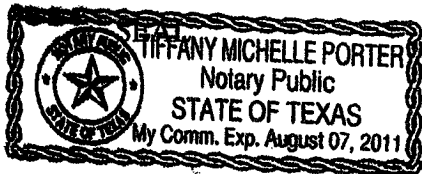

Dear Ms. Burrage:

This office is in receipt of information alleging that while employed as a Licensed Vocational Nurse at Dr. Janie Beauvais office, Humble, TX, from on or about January 2003 through about July 2003 you knowingly forged, altered, and falsified Vicodin prescriptions.

We have initiated an investigation into this matter to determine if you have violated any of the provisions of the Texas Occupations Code.

You are afforded this opportunity to respond to the allegations that have been made and to show that you have complied with all requirements of the law, i.e., the Texas Occupations Code, Chapter 302, for the retention of your license to practice vocational nursing in Texas. **You must respond in writing within thirty (30) days of receipt of this letter.**

We have enclosed Order Forms for a copy of the Texas Occupations Code and Rules and Regulations.

You may be interested in a provision of the Texas Occupations Code (302.410) for the Voluntary Surrender of a license. The return of the license along with your notarized statement that you no longer desire to be licensed will enable the Board to revoke your license without formal charges, notice or a hearing.

We are enclosing such an affidavit form for your consideration. To execute it, please sign the affidavit before a notary public and return it to the Board office, along with any vocational nursing license(s)/renewal form that you have in your possession.

One (1) year from the date the Board accepts the voluntary surrender, you may request a reinstatement hearing by submitting a letter to the Board office. You must be present at your reinstatement hearing, and the Board will require that you provide evidence of Rehabilitation/fitness to practice vocational nursing.
