On this day the Texas Board of Nursing, hereinafter referred to as the Board, considered the matter of JANE P. BAUERSFELD, AKA JANE PATRICIA BAUERSFELD, Registered Nurse License Number 544058, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may have violated Section 301.452(b)(10), Texas Occupations Code. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order offered by Katherine A. Thomas, MN, RN, Executive Director, subject to ratification by the Board.

FINDINGS OF FACT

1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license.
2. Respondent waived representation by counsel, informal proceedings, notice and hearing, and agreed to the entry of this Order.
3. Respondent is currently licensed to practice professional nursing in the State of Texas.
4. Respondent received a Baccalaureate Degree in Nursing from Texas Woman's University, Denton, Texas, on December 1, 1987. Respondent was licensed to practice professional nursing in the State of Texas on March 29, 1988.

6. On May 19, 1992, Respondent was issued the sanction of a Reprimand with Stipulations by the Board of Nurse Examiners for the State of Texas. A copy of the May 19, 1992, Consent Order, Findings of Fact, and Conclusions of Law is attached and incorporated, by reference, as part of this Order.
7. On September 22, 1992, the Board of Nurse Examiners for the State of Texas accepted the voluntary surrender of Respondent's license to practice professional nursing. A copy of the September 12, 1992, Order of the Board, Findings of Fact, and Conclusions of Law is attached and incorporated, by reference, as part of this Order.
8. On September 13, 1994, Respondent's license to practice professional nursing was Reinstated with Stipulations by the Board of Nurse Examiners for the State of Texas. A copy of the September 13, 1994, Amended Reinstatement Agreed Order, Findings of Fact, and Conclusions of Law is attached and incorporated, by reference, as part of this Order.
9. On or about March 24, 2009, while employed with Austin Lakes Hospital, Austin, Texas, Respondent lacked fitness to safely practice nursing in that she was sleeping while on duty. Respondent's conduct was likely to injure patients in that her condition affected her ability to recognize signs, symptoms, or changes in patients' conditions and prevented her from being able to make rational, accurate, and appropriate assessments, judgements, and decisions regarding care of her patients.
10. Respondent states that due to going without sleep over a period of thirty (30) hours, she was fatigued. She was a new employee and was hired to work the night shift from 7pm to 7am, three (3) days consecutively. Respondent states she had just started this job and did not want to call in and leave them short staffed. After she got there, she was struggling to stay awake.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violations of Section 301.452(b)(10), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(1)(E)&(5).
4. The evidence received is sufficient cause pursuant to Section 301.452(b), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 544058, heretofore issued to JANE P. BAUERSFELD, AKA JANE PATRICIA BAUERSFELD, including revocation of Respondent's license to practice professional nursing in the State of Texas.

ORDER

IT IS THEREFORE AGREED and ORDERED, subject to ratification by the Texas Board of Nursing, that Registered Nurse License Number 544058, previously issued to JANE P. BAUERSFELD, AKA JANE PATRICIA BAUERSFELD, to practice professional nursing in Texas is hereby SUSPENDED, with the suspension STAYED, and Respondent is hereby placed on PROBATION with the following agreed terms of probation:

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate privilege, if any, to practice nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Respondent's license is encumbered by this order the Respondent may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the Texas Board of Nursing and the Board of Nursing in the party state where Respondent wishes to work.

(1) RESPONDENT SHALL comply in all respects with the Nursing Practice Act, Texas Occupations Code, §§301.001 *et seq.*, the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.1 *et seq.* and this Order.

(2) RESPONDENT SHALL pay a monetary fine in the amount of five hundred dollars (\$500.00). RESPONDENT SHALL pay this fine within forty-five (45) days of entry of this Order. Payment is to be made directly to the Texas Board of Nursing in the form of cashier's check or U.S. money order. Partial payments will not be accepted.

(3) The Order of the Board issued to RESPONDENT on September 13, 1994, is still in effect in its entirety and RESPONDENT SHALL be responsible for completing the terms of that Order.

IT IS FURTHER AGREED and ORDERED that if during the period of probation, an additional allegation, accusation, or petition is reported or filed against the Respondent's license, the probationary period shall not expire and shall automatically be extended until the allegation, accusation, or petition has been acted upon by the Board.

IT IS FURTHER AGREED, that upon full compliance with the terms of this Order, all encumbrances will be removed from RESPONDENT's license and RESPONDENT shall be eligible for multistate licensure privileges, if any, to practice nursing in the State of Texas.

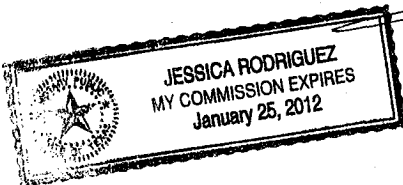

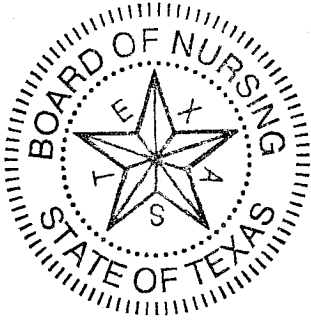

On this day came to be considered by the Board of Nurse Examiners for the State of Texas, hereinafter referred to as the Board, the Petition for Reinstatement of registered nurse license number 544058, held by JANE PATRICIA BAUERSFELD, hereinafter referred to as Petitioner.

An informal hearing was held on July 6, 1994, at the office of the Board of Nurse Examiners. Petitioner appeared in person. In attendance were Cady Crismon, M.S.N., R.N., C.N.S., Director of Practice and Compliance; Pettey Ross, Board Member; Roy Rawls, Assistant General Counsel; and Norma Rodriguez, Investigator.

FINDINGS OF FACT

1. Petitioner was licensed to practice professional nursing in the State of Texas.
2. Petitioner's license to practice professional nursing in the State of Texas was voluntarily surrendered to the Board of Nurse Examiners for the State of Texas, on or about September 22, 1992.
3. On or about June 17, 1994, Petitioner submitted a Petition for Reinstatement of License to practice professional nursing in the State of Texas.
4. Petitioner attended an inpatient treatment program, has maintained sobriety since February 13, 1993, has attended group counseling sessions on a regular basis, and attends Alcoholics Anonymous meetings several times a week.
5. Re-entry into nursing practice will be a stressful experience and petitioner will benefit from the support of stipulations.

### CONCLUSION OF LAW

1. That pursuant to applicable Texas law, the Board of Nurse Examiners for the State of Texas has jurisdiction over this matter.
2. That pursuant to Article 4525(c)(2), Revised Civil Statutes of Texas, as amended, the Board may reissue a license to practice professional nursing to a person whose license has been revoked, suspended, or surrendered.
3. That pursuant to Article 4525(d), the Board shall have right to probate the denial of an application for a license so long as the probated practitioner conforms to such stipulations as the Board may set out in terms of the probation.

### AGREED TERMS, STIPULATIONS AND CONDITIONS

IT IS THEREFORE AGREED, subject to ratification by the Board of Nurse Examiners, that license number 544058, heretofore issued to JANE PATRICIA BAUERSFELD, to practice professional nursing in the State of Texas, be and the same is hereby reinstated upon receipt of payment of re-registration fees.

(1) Petitioner shall comply in all respects with the Nursing Practice Act, Revised Civil Statutes of Texas as amended, art. 4513 et. seq., the Rules and Regulations Relating to Professional Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.01 et. seq. and the Terms, Stipulations and Conditions of this Order.

IT IS FURTHER AGREED, that the license issued to JANE PATRICIA BAUERSFELD, be subject to the following stipulations for three (3) year(s) of employment as a professional nurse:

(2) PETITIONER shall notify all potential employers in professional nursing of this Order of the Board and the stipulations on RESPONDENT's license. PETITIONER shall present a copy of this Order to each potential employer prior to employment.



(3) PETITIONER shall cause each potential employer to submit the Notification of Employment form to the Board's office within five (5) days of employment as a professional nurse.

(4) PETITIONER shall be supervised by a registered nurse who is on the premises. PETITIONER shall work only regularly assigned, identified and predetermined unit(s). PETITIONER shall not be employed by a nurse registry, temporary nurse employment agency or home health agency. PETITIONER shall not be self employed or contract for services. Multiple employers are prohibited.

(5) PETITIONER shall cause each employer to submit, on forms provided by the Board, periodic reports as to RESPONDENT's capability to practice professional nursing. These reports shall be completed by the registered nurse who supervises the PETITIONER. These reports shall be submitted to the office of the Board at the end of each three (3) months for three (3) year(s) of employment as a professional nurse.

(6) PETITIONER shall not practice as a professional nurse on the night shift, rotate shifts, work overtime, accept on-call assignments, or be used for coverage on any unit other than the assigned unit(s) for one (1) year of employment as a professional nurse.

(7) PETITIONER shall not practice as a professional nurse in any critical care area for one (1) year of employment as a professional nurse. Critical care areas include, but are not limited to, intensive care unit, emergency room, operating room, recovery room and labor and delivery units.

(8) PETITIONER shall not administer or have any contact with controlled substances, Nubain, or Stadol for one (1) year of employment as a professional nurse.

(9) PETITIONER shall abstain from the consumption of alcohol, Nubain, Stadol and/or the use of controlled substances, except as prescribed by a licensed practitioner for a legitimate purpose. PETITIONER shall cause the licensed practitioner to submit a written report identifying the medication, dosage and the date the medication was prescribed. The report shall be submitted directly to the office of the Board by the prescribing practitioner, within ten (10) days of the date of the prescription.

(10) PETITIONER shall submit to random periodic screens for controlled substances and alcohol.

For the first three (3) month period, random screens are to be performed at least once per week.

For the second three (3) month period, random screens are to be performed at least once per month.

For the remainder of the stipulation/probation period, random screens are to be performed at least once every three (3) months.

Specimens shall be screened for at least the following substances:

All screens shall be properly monitored and production of specimen personally observed by the employer's designee. A complete chain of custody shall be maintained for each specimen obtained and analyzed.

PETITIONER shall cause the employer/laboratory to send the written results of each random screen to the Office of the Board within five (5) days of the date that the screen is analyzed. If any screen tests positive for alcohol and/or controlled substances for which the PETITIONER does not have a valid prescription, the employer/laboratory shall report such results to the Board Office on the day that the results are received by calling the Board Office and reporting the positive results to an investigator.

(11) PETITIONER shall participate in therapy with a "professional counselor" possessing credentials approved by the Board. PETITIONER shall cause the therapist to submit written reports, on forms provided by the Board, as to the RESPONDENT's progress in therapy, rehabilitation and capability to safely practice professional nursing. The report must indicate whether or not the RESPONDENT's emotional stability is sufficient to provide direct patient care safely. Such reports are to be furnished each and every month for three (3) months or until PETITIONER is dismissed from therapy. The reports shall then be required at the end of each three (3) months for the duration of the stipulation, or until PETITIONER is dismissed from therapy.

(12) PETITIONER shall attend at least two (2) support group meetings each week and shall provide acceptable evidence of attendance. Acceptable evidence means the date of each meeting, the name of each group attended, and the signature or signed initials of the chairperson of each group attended by PETITIONER. The weekly meetings shall consist of a minimum of one (1) support group for substance abuse. PETITIONER shall submit the required evidence on the forms provided by the Board at the end of every three (3) months. No duplications, copies, third party signatures, or any other substitutions will be accepted as evidence.

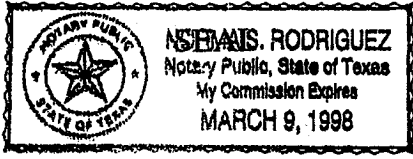



The Board of Nurse Examiners for the State of Texas, hereinafter referred to as the Board, during a regularly scheduled meeting, accepted the voluntary surrender of professional nurse license number 544058, issued to JANE P. BAUERSFELD. This action was taken in accordance with Article 4525(b), Revised Civil Statute of Texas, as amended.

At the meeting, Morris H. Parish, Ph.D., President of the Board, presided and a quorum of the Board was present. The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. That Jane P. Bauersfeld holds a license to practice professional nursing in the State of Texas, which is in delinquent status.
2. That Jane P. Bauersfeld submitted a notarized statement and professional nurse license number 544058 to the Board voluntarily surrendering the right to practice professional nursing in Texas.

CONCLUSIONS OF LAW

1. That pursuant to Article 4525, Revised Civil Statutes of Texas, as amended the Board has jurisdiction over this matter.
2. That, under Article 4525(b), Revised Civil Statutes of Texas, as amended, the Board has the authority to revoke said license without the necessity of formal charges, notice, or opportunity of hearing.

CONSENT ORDER

Following receipt of information, a hearing was held on April 15, 1992, at the office of the Board of Nurse Examiners, hereinafter referred to as the Board, in accordance with Article 4525(b), Revised Civil Statutes of Texas, as amended. JANE PATRICIA BAUERSFELD, license number 544058, hereinafter referred to as Respondent, was in attendance. The Executive Director of the Board presided at the hearing and makes the following:

FINDINGS OF FACT

1. Respondent is currently licensed to practice professional nursing in the State of Texas.
2. Respondent, while employed with Health Care Rehabilitation Hospital, Austin, Texas, engaged in the intemperate use of codeine, on or about December, 1991.
3. Respondent, while employed at Sierra Health Care Center, engaged in the intemperate use of Fiorinal, on or about February, 1992.
4. Respondent desires to continue her career in professional nursing.

CONCLUSIONS OF LAW

1. The Board has jurisdiction over this matter.
2. Based upon the evidence received, Respondent is in violation of Article 4525(a) (8), Revised Civil Statutes of Texas, as amended.
3. The evidence presented constitutes sufficient evidence to take action under powers granted by Article 4525(b), Revised Civil Statutes of Texas, as amended.



### RESPONDENT'S STATEMENT OF AGREEMENT

By signature on this Order, I agree to entry of this Order dispensing with the need for further disciplinary action in this matter. I understand that:

1. This Order is subject to ratification by the Board at their next regularly scheduled meeting;
2. If this Order is ratified by the Board, my license to practice professional nursing in the State of Texas will be issued a reprimand with stipulations; and
3. I have the right to legal counsel prior to entering into this Order.

I have reviewed this Order. I consent to the issuance of a reprimand on my license to practice professional nursing in the State of Texas.

I further consent to adhere to the following stipulations for three (3) years:

(1) Respondent shall return her current certificate of re-registration (wallet-size) to the office of the Board immediately for appropriate notation.

(2) Respondent shall cause Cocoon Aftercare Treatment Program to submit a written report to the Board office, as to Respondent's progress in therapy, rehabilitation and capability to safely practice professional nursing. Said report must be submitted to the Board's office within six (6) months from the date of this Order.

(3) Respondent shall submit to a neuropsychiatric evaluation supervised by a Board certified psychiatrist within six (6) months from the date of this Order. Respondent shall cause the supervising psychiatrist to

submit the result of the neuropsychiatric evaluation to the Board's office within six (6) months from the date of the Board Order.

(4) Respondent shall notify each present employer in professional nursing of this Order of the Board and the stipulations on Respondent's license. Respondent shall present a copy of this Order to each present employer within five (5) days of notification of this Order. Respondent shall notify all potential employers in professional nursing of this Order of the Board and the stipulations on Respondent's license. Respondent shall present a copy of this Order to each potential employer prior to employment.

(5) Respondent shall cause each present employer in professional nursing to submit the Notification of Employment form to the Board's office within ten (10) days of notification of this Order. Respondent shall cause each potential employer to submit the Notification of Employment form to the Board's office within five (5) days of employment as a professional nurse.

(6) During Respondent's employment as a professional nurse, Respondent shall cause each employer to submit, on forms provided by the Board, periodic reports as to Respondent's capability to practice professional nursing. These reports shall be submitted to the office of the Board at the end of each three months for three (3) years of employment as a professional nurse. The reports shall be received by the office of the Board no later than the due date indicated on the report form.

(7) The terms of this Order can only be served while Respondent is employed as a professional nurse in a hospital, nursing home, or other clinical practice setting. The Respondent shall be supervised by a professional nurse who is on the premises. Respondent shall work only on

regularly assigned, identified and predetermined unit(s). The Respondent shall not be employed by a nurse registry, temporary nurse employment agency or home health agency. Respondent shall not be self employed. Multiple employers are prohibited.

(8) Following entry of this Order, Respondent shall not practice as a professional nurse in any critical care areas for one (1) year of employment as a professional nurse. Critical care areas include but are not limited to intensive care unit, emergency room, operating room, recovery room and labor and delivery units.

(9) Following entry of this Order, Respondent shall not practice as a professional nurse on the night shift, rotate shifts, work overtime, accept on-call assignments, or be used for coverage on any unit other than the assigned unit(s) for one (1) year of employment as a professional nurse.

(10) Following entry of this Order, Respondent shall not administer or have any contact with Controlled Substances, Nubain, or Stadol for one (1) year of employment as a professional nurse.

(11) Respondent shall abstain from the consumption of alcohol, Nubain, Stadol and/or the use of Controlled Substances, except as prescribed by a licensed practitioner for a legitimate purpose. Respondent shall cause the licensed practitioner to submit a written report identifying the medication, dosage and the date the medication was prescribed. The report shall be submitted to the office of the Board within ten (10) days of the date of the prescription.

(12) Respondent shall submit to random periodic screens for Controlled Substances and alcohol at least once every week, for three (3) months. The screens shall then be required at least once every month for

three (3) months. The screens shall then be required at least once every three (3) months for the duration of the stipulation period. All screens shall be properly monitored and production of specimen personally observed by the employer's designee. A complete chain of custody shall be maintained for each specimen obtained and analyzed. Respondent shall cause the employer/laboratory to send written laboratory results of the screens to the office of the Board. If any specimen tests positive for alcohol and/or Controlled Substances, for which Respondent does not have a valid prescription, the employer/laboratory shall report such results to the Board immediately. The results shall be received by the office of the Board no later than the due date.

(13) Respondent shall participate in therapy with a "professional counselor" possessing credentials approved by the Board. Respondent shall cause the therapist to submit written reports, on forms provided by the Board, as to the Respondent's progress in therapy, rehabilitation and capability to safely practice professional nursing. The report must indicate that the Respondent's emotional stability is sufficient to provide direct patient care safely. Such reports are to be furnished each and every month for three (3) months or until Respondent is dismissed from therapy. The reports shall then be required at the end of each three (3) months for the duration of the stipulation period, or until Respondent is dismissed from therapy. The original forms shall be received in the Board's office no later than the due date indicated on the report form.


(14) Respondent shall attend at least two (2) support group meetings each week and shall provide acceptable evidence of attendance. Acceptable evidence means the date of each meeting, the name of each group

attended, and the signature or signed initials of the chairperson of each group attended by Respondent. The weekly meetings shall consist of a minimum of one (1) impaired nurse support group and one (1) support group for substance abuse. Respondent shall submit the required evidence on the original forms provided by the Board at the end of every three (3) months for a period of three (3) years. No duplications, copies, third party signatures, or any other substitutions will be accepted as evidence. 
