- 09/11/08 Untimely Motion for Rehearing filed by Shonda Okema Favaroth.
- 11/12/08 Motion for Rehearing **GRANTED** by the Eligibility & Disciplinary Committee of the Board.
- 11/12/08 Order issued **GRANTING** the Motion for Rehearing thereby removing the Revoked status and placing LVN license No. 203847 in **CURRENT** status.
