On this day, the Texas Board of Nursing, hereinafter referred to as the Bo accepted the voluntary surrender of Registered Nurse License Number 668686, issued to ED EUGENE WILSON, hereinafter referred to as Respondent. This action was taken in accordance with Section 301.453(c) of the Texas Occupations Code.

Respondent waived representation by counsel, informal conference and hearing, and agreed to the entry of this Order.

The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was provided to Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license.
2. Respondent waived representation by counsel, notice and hearing, and agreed to the entry of this Order.
3. Respondent is currently licensed to practice professional nursing in the State of Texas.
4. Respondent received an Associate Degree in Nursing from Del Mar College, Corpus Christi, Texas, on May 7, 1999. Respondent was licensed to practice professional nursing in the State of Texas on May 31, 2000.
5. Respondent's professional nursing employment history includes:

such misappropriation in that two vials of Fentanyl were found on his person when he was stopped for a traffic violation by the Texas Department of Public Safety, San Antonio, Texas. Respondent's conduct was likely to defraud the facility and patients of the cost of the medications.

10. On or about August 14, 2007, Respondent plead Nolo Contendere to "Possession of Marijuana < 2 oz.," a Class B Misdemeanor (committed on June 24, 2007), in the Bexar County Court at Law, San Antonio, Texas, Cause Number 220195. An adjudication of guilt was deferred, and Respondent was placed on probation for a period of twelve (12) months and ordered to pay a fine and court costs.
11. On or about October 8, 2007, Respondent was convicted of "Driving While Intoxicated," a Class B Misdemeanor (committed on August 25, 2006), in the 148th Judicial District Court of Nueces County, Corpus Christi, Texas, Cause Number 06002951-E. Respondent was placed on probation for a period of twenty-four (24) months and ordered to pay a fine and court costs.
12. On or about October 8, 2007, Respondent plead No Contest to "Failure to Stop and Render Aid Injury/Death," a Felony (committed on August 25, 2006), in the 148th Judicial District Court of Nueces County, Corpus Christi, Texas, Cause Number 06002951-E. An adjudication of guilt was deferred, and Respondent was placed on probation for a period of sixty (60) months and ordered to pay a fine and court costs. As part of Respondent's plea under Cause Number 06002951-E, a charge of "Intoxicated Assault With a Vehicle Serious Bodily Injury," was dismissed.
13. Respondent states that he is currently unable to financially afford weekly drug screens. Respondent admits that his life is in "complete shambles," and he knows that alcohol and drugs will only make things worse. Respondent states that his date of sobriety is July 1, 2007.
14. Respondent, by his signature to this Order, expresses his desire to voluntarily surrender his license to practice nursing in the State of Texas.
15. The Board policy implementing Rule 213.29 in effect on the date of this Agreed Order provides discretion by the Executive Director for consideration of conditional reinstatement after proof of twelve (12) consecutive months of abstinence from alcohol and drugs followed by licensure limitations/stipulations and/or peer assistance program participation.
16. The Board finds that there exists serious risks to public health and safety as a result of impaired nursing care due to intemperate use of controlled substances or chemical dependency.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555, the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violations of Section 301.452(b)(2), (3) & (10), Texas Occupations Code, and 22 TEX. ADMIN. CODE §§217.12(1) & (22)(effective to September 28, 2004) and 217.12(6)(G), (11)(B) & (13)(effective on September 28, 2004).
4. The evidence received is sufficient cause pursuant to Section 301.453(d), Texas Occupations Code, to take disciplinary action against Registered Nurse License Number 668686, heretofore issued to EDDIE EUGENE WILSON, including revocation of Respondent's license to practice nursing in the State of Texas.
5. Under Section 301.453(c), Texas Occupations Code, the Board has the authority to accept the voluntary surrender of a license.
6. Under Section 301.453(d), Texas Occupations Code, as amended, the Board may impose conditions for reinstatement of licensure.
7. Any subsequent reinstatement of this license will be controlled by Section 301.453(d), Texas Occupations Code, and 22 TEX. ADMIN. CODE §213.26-.29, and any amendments thereof in effect at the time of the reinstatement.

ORDER

NOW, THEREFORE, IT IS AGREED and ORDERED that the VOLUNTARY SURRENDER of Registered Nurse License Number 668686, heretofore issued to EDDIE EUGENE WILSON, to practice nursing in the State of Texas, is accepted by the Texas Board of Nursing. In connection with this acceptance, the Board imposes the following conditions:

1. RESPONDENT SHALL immediately deliver the wallet-sized license, heretofore issued to EDDIE EUGENE WILSON, to the office of the Texas Board of Nursing.
2. RESPONDENT SHALL NOT practice professional nursing, use the title "registered nurse" or the abbreviation "RN" or wear any insignia identifying

himself as a registered nurse or use any designation which, directly or indirectly, would lead any person to believe that RESPONDENT is a registered nurse during the period in which the license is surrendered.

3. RESPONDENT SHALL NOT petition for reinstatement of licensure until: one (1) year has elapsed from the date of this Order; and, RESPONDENT has obtained objective, verifiable proof of twelve (12) consecutive months of sobriety immediately preceding the petition.
4. Upon petitioning for reinstatement, RESPONDENT SHALL satisfy all then existing requirements for relicensure.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate privilege, if any, to practice nursing in the State of Texas.

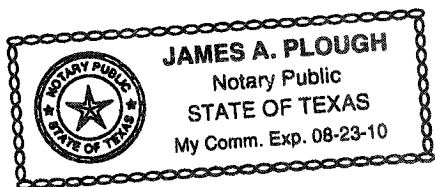




