On this day the Texas Board of Nursing, hereinafter referred to as the Boa considered the matter of JAIME EDUARDO CERVANTES, Vocational Nurse License Number 160377, hereinafter referred to as Respondent.

Information received by the Board produced evidence that Respondent may have violated Section 301.452(b)(2)&(10), Texas Occupations Code. Respondent waived representation by counsel, informal conference, notice and hearing, and agreed to the entry of this Order offered on September 19, 2008, by Katherine A. Thomas, MN, RN, Executive Director.

FINDINGS OF FACT

1. Prior to the institution of Agency proceedings, notice of the matters specified below in these Findings of Fact was served on Respondent and Respondent was given an opportunity to show compliance with all requirements of the law for retention of the license.
2. Respondent waived representation by counsel, informal conference, notice and hearing, and agreed to the entry of this Order.
3. Respondent is currently licensed to practice vocational nursing in the State of Texas.
4. Respondent received a Certificate of Nursing from Texas Southmost College, Brownsville, Texas on August 16, 1996. Respondent was licensed to practice vocational nursing in the State of Texas on October 25, 1996.
5. Respondent's vocational nursing employment history is unknown.

6. On or about July 19, 1996, Respondent submitted an Application by Examination to the Board of Vocational Nurse Examiners for the State Texas in which she provided false, deceptive, and/or misleading information, in that she answered "No" to the following question:

"Have you ever been convicted of a felony or misdemeanor other than a minor traffic violation?"
7. On or about March 25, 2008, Respondent was required to comply with a random criminal background audit check. The results revealed the following non disclosed criminal history:
8. On February 24, 1986, Respondent entered a plea of "Guilty" to Driving While Intoxicated (a misdemeanor offense committed on January 10, 1986), in the County Court at Law #2 Cameron County, Texas, under Cause Number 86-cc-482-B. Respondent was order to serve thirty (30) days in confinement and pay a two hundred and fifty dollar (\$250.00) fine. Order Discharging Defendant from Misdemeanor Probation was signed and dated March 24, 1988.
9. On April 24, 1991, Respondent entered a plea of "Guilty" to Pulic Intoxicated (a misdemeanor offense committed on January 10, 1986), at the Pharr Police Department in Pharr, Texas, under Cause Number 91-04-I-769. Respondent was order to pay a fine of one hundred and seventeen dollars (\$117.00).
10. On August 19, 1991, Respondent entered a plea of "Guilty" to Driving While Intoxicated 2nd Offense(a misdemeanor offense committed on July 20, 1991), in the County Court at Law # 1, Cameron County, Texas, under Cause Number 91-CCR-0004633-A. Respondent was ordered to Serve twenty-four (24) months probation, pay a three hundred and fifty dollar (\$350.00) fine, participate in Alcoholics Anonymous, and participate in thirty (30) hours of Alcohol Intervention Program.

CONCLUSIONS OF LAW

1. Pursuant to Texas Occupations Code, Sections 301.451-301.555 , the Board has jurisdiction over this matter.
2. Notice was served in accordance with law.
3. The evidence received is sufficient to prove violations of Section 301.452(b)(2)&(10), Texas Occupations Code, and 22 TEX. ADMIN. CODE §217.12(6)(I))
4. The evidence received is sufficient cause pursuant to Section 301.452(b), Texas Occupations Code, to take disciplinary action against Vocational Nurse License Number 160377, heretofore issued to JAIME EDUARDO CERVANTES, including revocation of Respondent's license to practice vocational nursing in the State of Texas.

ORDER

IT IS THEREFORE AGREED and ORDERED, subject to ratification by the Texas Board of Nursing, that RESPONDENT SHALL receive the sanction of a REMEDIAL EDUCATION WITH A FINE, and RESPONDENT SHALL comply in all respects with the Nursing Practice Act, Texas Occupations Code §§301.001 *et seq.*, the Rules and Regulations Relating to Nurse Education, Licensure and Practice, 22 TEX. ADMIN. CODE §211.1 *et seq.* and this Order.

IT IS FURTHER AGREED and ORDERED that this Order SHALL be applicable to Respondent's multistate licensure privilege, if any, to practice vocational nursing in the State of Texas.

IT IS FURTHER AGREED and ORDERED that while Respondent's license is encumbered by this Order, Respondent may not work outside the State of Texas pursuant to a multistate licensure privilege without the written permission of the State of Texas and the Board of Nursing in the party state where Respondent wishes to work.

IT IS FURTHER AGREED that:

(1) RESPONDENT SHALL deliver the wallet-sized license issued to JAIME EDUARDO CERVANTES to the office of the Texas Board of Nursing within ten (10) days of the date of ratification of this Order for appropriate notation.

(2) RESPONDENT SHALL pay a monetary fine in the amount of five hundred dollars (\$500.00). RESPONDENT SHALL pay this fine within forty-five days of entry of this Order. Payment is to be made directly to the Texas Board of Nursing in the form of cashier's check or U.S. money order. Partial payments will not be accepted.

(3) RESPONDENT SHALL, within one (1) year of entry of this Order, successfully complete a course in Texas nursing jurisprudence and ethics. RESPONDENT SHALL obtain Board approval of the course prior to enrollment only if the course is not being offered by a pre-approved provider. Home study courses and video programs will not be approved. In order for the course to be approved, the target audience shall include nurses. It shall be a minimum of six (6) contact hours in length. The course's content shall include the Nursing Practice Act, standards of practice, documentation of care, principles of nursing ethics, confidentiality, professional boundaries, and the Board's Disciplinary Sanction Policies regarding: Sexual Misconduct; Fraud, Theft and Deception; Nurses with Substance Abuse, Misuse, Substance Dependency, or other Substance Use Disorder; and Lying and Falsification. Courses focusing on malpractice issues will not be accepted. RESPONDENT SHALL CAUSE the sponsoring institution to submit a Verification of Course Completion form, provided by the Board, to the Office of the Board to verify RESPONDENT's successful completion of the course. This course shall be taken in addition to any other courses stipulated in this Order, if any, and in addition to any continuing education requirements the Board has for relicensure. *Board-approved courses may be found at the following Board website address: <http://www.bon.state.tx.us/disciplinaryaction/stipscourses.html>.*

IT IS FURTHER AGREED, that upon full compliance with the terms of this Order, RESPONDENT SHALL be issued an unencumbered license and multistate licensure privileges, if any, to practice vocational nursing in the State of Texas.

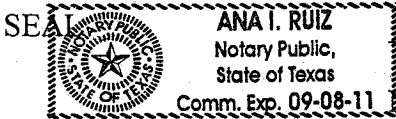
RESPONDENT'S CERTIFICATION
