ORDER GRANTING MODIFICATION

An Agreed Order of the Board was entered on August 9, 2016, and an Order Granting Modification was entered on December 5, 2017, for VERGIE MAE BRANNON, Registered Nurse License Number 622930, hereinafter referred to as PETITIONER. PETITIONER filed a Request for Exception to the Agreed Order on March 12, 2018.

A public meeting of the Eligibility and Disciplinary Committee of the Board, hereinafter referred to as the Committee, was held on June 12, 2018, at 333 Guadalupe Street, Tower 3, Suite 460, Austin, Texas, to consider the Petition for Exception and supporting documents filed by PETITIONER.

PETITIONER was not in attendance at the hearing.

Board Members in attendance were: Patricia Clapp, BA; Laura Disque, MN, RN; and Kathy Leader-Horn, LVN.

After review and due consideration of the file petition, the Committee voted to **GRANT MODIFICATION** of the August 9, 2016, Agreed Order.


IT IS THEREFORE ORDERED that Petitioner is required to comply with and complete all of the requirements of the August 9, 2016, Agreed Order, except that Stipulation(s) Number Five (5), Subsections C and D is/are substituted with the following:

C. Incident Reporting: While under the remaining terms of this Order, PETITIONER SHALL CAUSE each employer to immediately submit any and all incident, counseling, variance, unusual occurrence, and medication or other error reports involving PETITIONER, as well as documentation of any internal investigations regarding action by PETITIONER, to the attention of Monitoring at the Board's office.

D. Nursing Performance Evaluations: While under the remaining terms of this Order, PETITIONER SHALL CAUSE each employer to submit, on forms provided to the PETITIONER by the Board, periodic reports as to PETITIONER's capability to practice nursing. These reports shall be completed by the employer and submitted to the office of the Board at the end of each three (3) month quarterly period for of employment as a nurse.

All other terms and conditions of the August 9, 2016, Agreed Order remain unchanged and Petitioner is responsible for complying with those terms as written. Further, this Order supercedes the Order Granting Modification entered on December 5, 2017.
