**AGREED BOARD ORDER**

On this day came to be considered by the Board of Nurse Examiners the matter of vocational nurse license number 147399 held by RANDY DALE CHUMLEY, hereinafter called Respondent.

By letter, the Board of Nurse Examiners sent preliminary notice to Respondent of its intent to take disciplinary action with respect to said license held by Respondent, as a result of a complaint and subsequent investigation. Said investigation produced evidence indicating that Respondent has engaged in unprofessional or dishonorable conduct that, in the Board's opinion, is likely to deceive, defraud, or injure the public, in violation of Texas Occupations Code, Chapter 302, Section 302.402 (a) (10), in the following manner:

I.

a. Respondent was employed as a licensed vocational nurse at SCCI Hospital in Amarillo, Texas from about June 19, 2001 through about October 27, 2002.

b. While so employed at said facility, on or about October 25, 2002, Respondent verbally abused resident M.J. by yelling at facility staff in said patient's presence to "keep his ass down the hall or I will hit him" and "he is in my fucking way". Furthermore, Respondent later contacted the facility by phone and made verbal threats against employees.

c. On or about June 9, 1995, Respondent was convicted of the Class C Misdemeanor Offense of: ISSUANCE OF A BAD CHECK, in the County Court at Law of Potter County, Texas, under Cause Number 65898P. As a result of said conviction, Respondent was assessed a fine of \$168.00.

d. On or about June 19, 1996, Respondent submitted an application for renewal to the Board office and falsely checked "no" in response to item (15b): "Were you convicted of a misdemeanor other than a minor traffic violation since your last renewal?"

e. Respondent has been convicted of a crime, which the Board considers to be directly related to the duties and responsibilities of a Licensed Vocational Nurse. Said conviction is inconsistent with the basic duties and responsibilities inherent in the occupation of vocational nursing in that said occupation requires the maintenance of accurate and complete records, and safeguarding personal property of the patient, client, and employer.

By Respondent's signature on this Order, Respondent neither admits nor denies the truth of the matters previously set out in this Order with respect to the above-mentioned investigation. By Respondent's signature on this Order, Respondent acknowledges that they have read and understood this Order and have approved it for consideration by the Board.

By their notarized signature on this Order, Respondent does hereby waive the right to a formal Complaint, Notice of Hearing and a Public Hearing held before an Administrative Law Judge with the State Office of Administrative Hearings, and to judicial review of this disciplinary action. Notice of this disciplinary action will appear in the Board's newsletter sent to Texas employers.

ORDER OF THE BOARD

**NOW THEREFORE, IT IS ORDERED**, subject to ratification by the Board of Vocational Nurse Examiners that license number 147399, heretofore issued to RANDY DALE CHUMLEY to practice vocational nursing in the State of Texas be, and the same is hereby suspended until such time as Respondent provides the Board office with a satisfactory report from his/her psychiatrist, stating that Respondent is deemed psychologically fit to carry out the duties and responsibilities for a Licensed Vocational Nurse. Upon receipt of said satisfactory psychiatrist's statement the suspension of said license shall be automatically lifted and the license reinstated, without stipulations.

This Agreed Order shall not be effective or take effect and become enforceable in accordance with its terms until ratified by a majority of the Board present and voting, at its next regularly called session.


